In Memoriam George Waldo Berrier, Jr. November 27, 1929 -September 3, 2007



It is with sadness that we report that AMBA President and CEO passed away unexpectedly on Labor Day. Chapter members met with George whenever they went to Reno for either the National Wild Horse and Burro Show or the Western States Wild Horse and Burro Expo. He loved his horses and at one time had 30 or so animals from the Virginia Range at his ranch in California. He allowed visitors to ride his mustangs and took great pleasure in riding into the "back country" to do wild horse census surveys. He will be greatly missed by all who knew him.

NEWS AND NOTES

As a member of the AMBA Advisory Board and the AMBA Eastern States Coordinator, CEO responsibilities for AMBA have somehow been passed to Mark (on a temporary basis). He has been in contact with the other members of the Advisory Board

as well as George's son and daughter and has received some of the AMBA records from them. However, there are still missing pieces. Chapter member Debbie Edwards has helped establish a data base for new animal registrations and memberships. As of December 1, we have registered 63 animals and recorded 27 new memberships.
